ABOUT THE COUNTY OF MINBURN

The County of Minburn is located in the south of the Alberta HUB region. Alberta HUB is a partnership of municipalities, First Nations, Metis Settlements, post-secondary educational institutions, and business/industry in northeastern Alberta meant to enhance the quality of life and economic interests of this region. The County is strategically located with Highway 16 (Yellowhead) running east and west and Highway 36 (Veterans Memorial Highway) running north and south. Given its location, the County is a center for road, railway, and air transportation services. There are industrial areas within the County and prime downtown office space located in the urban centers, making the County of Minburn a prime business development location.

OUR TOP INDUSTRIES



Agriculture

Of the County's 586,495 acres (2016), 85% is cultivated land. Wheat, canola, barley and oats are the major commodities. The farming community represents a skilled and hard-working labour force with expertise in assembly line work, welding and metal fabrication. The County is also a highly productive livestock area with grazing reserve of over 20 sections of land. Beef producers are mainly cow-calf operators.



Oil and Gas

Shallow low pressure gas lies underneath most of the County, and a large heavy oil field with over 400 wells is located in the southeast. Oil and gas lease sites and pipeline development has increased significantly over the past few years and that trend is expected to continue. With lower land costs, excellent infrastructure and an educated labour force, the County of Minburn is an excellent choice for investment.



Tourism

Part of the Kalyna Country ecomuseum and on the Yellowhead Highway, the County of Minburn has excellent recreational opportunities. Superb leisure facilities attract major sports tournaments, encourage family participation, and allow for yearround recreation programs. The County offers a diverse outdoor experience at its campgrounds, picnic sites and parks. Hunting and fishing attract residents and visitors.



Transportation

Highway 16 is a major east-west corridor, linking the County to the Port of Prince Rupert. Highway 36 is a High Load Corridor with access to vast oil sands development areas. The intersection of Highways 16 and 36 has been identified by the province as a future interchange location. At this strategic location, approximately 1,500 acres of land has been identified for future industrial development and commercial uses.
