


Smoky Lake County

Smoky Lake County's agriculture sector strength supports opportunities for investment in value - added Agriculture. Our regional climate and microclimates support specialty and common commodity crops. There are a variety of agricultural resources including low-cost grazing lands, high productive crop lands, ready access to processing facilities, a large Alberta market and a growing local food economy. Lower operating costs support this primary industry in the County.

The Smoky Lake region has seen moderate growth with gross farm cash receipts increasing 16% since 2016, hitting over \$105 million in 2021. The Agriculture sector is supported by businesses located across the Region and highway and rail services in close proximity.

Smoky Lake County has an excellent highway transportation network, which includes direct connections to U.S. and Mexico markets and to western ports. Air service is available via the Edmonton International Airport, 120 km southwest. Both CN Rail and daily bus, freight and couriers serve the County.

Highway 36 is the high load corridor defined as the Eastern Alberta Trade Corridor, connecting to U.S. and Mexican markets.
